### **Declaration of Conformity to EU RoHS**

Products listed below that are manufactured by Brumall Manufacturing are in compliance with The European RoHS Directive 2015/863/EC, which restricts the following substances in electrical and electronic equipment. In addition, this declaration of conformity is issued under the sole responsibility of Brumall Manufacturing. Brumall Manufacturing does not use any of the Restricted Substances as components in its mechanical wire termination products except in some listed products that include permitted levels of lead (Pb) under the exemption Annex paragraph 6(a)-I,(b)-I,(c).

Lead (Pb) Exemption 6 free machining alloys for only parts listed "9 of 10"

Products do not contain Deca Brominated Diphenyl Ether (Deca BDE) legislated under the provisions of the European Commission Decision of 13 October 2005 (2005/717/EC), and do not contain as intentional additives Perfluoroocantylsulfonates (PFOS) legislated under the provisions of the European Parliament and Council Directive 2006/122/EC (30th amendment to EU Directive 76/769/EEC).

### TSCA Section 6(h)

Products do not contain phenol, isoproylated phosphate(3:1) (PIP (3:1)); decabromodiphenyl ether (DecaBDE); 2,4,6-Tris(tert-butyl)phenol (2,4,6-TTBP); hexachlorobutadiene (HCBD); or pentachlorothiophenol (PCTP) as legislated under Section 6(h) of the Toxic Chenicals under the Toxic Substances Control Act (TSCA). Brumall Mfg. does not manufacture, process, or distribute these Persistent, Bioaccumulative, and Toxic (PBT) chemicals.

### **REACH**

It is hereby certified that Brumall Manufacturing complies with the Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration Evaluation Authorization and Restriction of Chemicals (REACH) Directives to this extent: Brumall Mfg. is a manufacturer of articles. Brumall Manufacturing has taken the initiative to review itself and its suppliers for the (240) substances that are under consideration for treatment as Substances of Very High Concern (SVHC) candidates.

Brumall Manufacturing has confirmed to the best of its belief, that its products do not contain any of the listed substances in concentration >0.1% weight per supplied article, substance or preparation weight. The exception would be items that include lead. In such items the percent weight of lead is no greater than is allows under RoHS exception Annex paragraph 6(a)-I, (b)-I and (c), Version 4.0 – June 2017.

## California Prop 65 Information

Proposition 65 requires business to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. Proposition 65 became law in November 1986, when California voters approved it by a 63-37 percent margin. The official name of the Proposition 65 is the safe Drinking Water and Toxic Enforcement Act of 1986.

### Warning Requirements
